

# Free Summer Student Housing Program Guidelines

Sunday, May 22 - Saturday, August 13, 2022

(revised: 3/31/22)

MCLA will be offering free summer housing to MCLA students who register for and successfully complete a minimum of eight credits during the 2022 summer school sessions **AND** contract to live in on-campus housing for the 2022-2023 academic year.

## To Take Advantage of This Program:

- Participate in the Returning Student Housing Assignment Process (HAP). The deadline to submit paperwork for this process is Friday, 4/15. Refer to the e-mail you received on Thursday, 3/31 for additional information about completing a priority HAP application.
- Register and pay your deposit for the Summer Student Housing Program (Sunday, May 22nd - Saturday, August 13th) by the Friday, 4/22 deadline. Information about the Summer Student Housing Program is available on the Campus Housing Web Page.
- Register for summer classes no later than Friday, 4/22.

## Important Information:

- If you enroll in this program and do not successfully complete a minimum of eight credits during the 2022 summer school sessions and/or do not fulfill your commitment to live on campus during the 2022-2023 academic year, you will be billed the full cost of your summer housing.
- Summer 2022 housing rates are located on the Summer Student Housing Program application.
- Students who participate in credit-free internships and undergraduate research programs during the summer of 2022 and contract to live on campus during the 2022-2023 academic year may also request free housing. These requests will be reviewed and are subject to housing availability with priority given to those in credit-bearing experiences.
- Students participating in Study Away and Study Abroad programs in the coming academic year are eligible to participate in this program provided they contract to live on campus for the 2022-2023 semester during which they are not studying away.
- All free summer housing will be in design doubles (with a roommate) and design singles in the Flagg Townhouse Apartment Complex. Students are not guaranteed their first room-type preference. Students in the free housing program who opt for a premium single (a design double for one person) will be responsible for paying the premium single upcharge. Priority placement in premium singles will be given to those contracting summer housing at full cost.
- Students must maintain a record of *good disciplinary standing* in order to participate in this program. Failure to do so during the summer could lead to removal from summer housing.
- A \$100 non-refundable deposit is due when the Summer Student Housing Program application is submitted. Students who believe they have a financial issue that supports a waiver of the deposit should make an appointment to speak with a Student Financial Services staff member prior to Friday, April 15th. Deposit waivers will not be granted after that date.
- Participation in this program may affect your overall financial aid award for the summer of 2022. Please contact the Student Financial Services office to review how you may be impacted.
- Official records in the Residence Life & Housing and Student Records offices will be checked to assure compliance with the requirements of this program.
- Prior to moving in, students approved to participate in this program will be required to sign a *Memorandum of Understanding* to affirm their understanding of the terms and conditions of the program.
